CONFERENCE BACKGROUND

TERMS AND CONDITIONS



General Terms and Conditions

- 1. The Public Health Association of Australia's (PHAA) sponsorship and exhibition agreements are governed by PHAA's Sponsorship Protocol. The following criteria must be met by all sponsors and exhibitors:
 - a. Common aims: the purpose, aims, values and principles of the sponsoring or exhibiting body must be compatible with those of PHAA's.
 - b. Acceptable business (and/or product) and no use of product name: companies whose profits depend at least in part on, manufacturing or production, distribution, advertising or promotion, marketing, sponsorship, retailing or representing products and practices that when used as intended can be problematic or harmful to public health are explicitly excluded as sponsors for PHAA activities. These include, but are not limited to, tobacco, weapons, alcohol, junk food and companies linked to or promoting gambling.
 - c. Acceptable commercial practices (including marketing): the known commercial practices of the sponsoring body (in Australia and elsewhere) must be consistent with good practice within the industry and applicable regulations and standards. The sponsoring body does not direct market or promote their brand, organisation, retail establishment or explicitly excluded products (see b above) to children or vulnerable groups.
- 2. By submitting a Booking Form for a sponsorship or exhibition opportunity you agree that you meet the criteria listed above and agree to comply with and be bound by these Sponsorship & Exhibition Terms and Conditions.
- 3. PHAA reserves the right to amend the sponsorship and exhibition packages to benefit the sponsor, exhibitor, conference, and delegates.

Sponsorship & Exhibition Bookings

- 4. All bookings for sponsorship and exhibition opportunities are subject to approval by PHAA and must be consistent with and in support of PHAA's objectives, policies, and guidelines. PHAA reserves the right, at their absolute discretion, to deny any offer of sponsorship and/or exhibition.
- 5. If your sponsorship and/or exhibition booking is approved, you will be forwarded a Sponsorship and/or Exhibition Contract. The contract is the only recognised confirmation of a sponsorship and/or exhibition package. No package will be confirmed until this order has been signed by both parties and full payment has been received. The amount is payable 14 days from the date of the tax invoice and all prices are quoted inclusive of GST. If the amount is not received within 14 days of the invoice the sponsorship and/or exhibition package may be made available for resale.
- 6. Once the Sponsorship and/or Exhibition contract has been signed by both parties and full payment has been received, you will be deemed a "Sponsor" or "Exhibitor" of the Event and will be entitled to the benefits associated with the package as specified in the contract. Partners and exhibitors are responsible for providing artwork, logos, and text as relevant by the due dates. PHAA takes no responsibility for publishing artwork, logos or text received after the due date or in an incorrect format.

Cancellation Policy

- 7. For cancellations received in writing by PHAA 30 days before the event start date, a service fee of 50% of total fees will apply. No refunds will be made for cancellations made less than 30 days before the event start date.
- 8. All cancellations must be notified to PHAA Events Team (events@phaa.net.au) by email before the cancellation can be processed. Cancellations will not be deemed to be received until you have written confirmation from PHAA. If you have not received acknowledgment within two (2) business days, please contact PHAA Events Team (02) 6171 1312. If the cancellation is not received in writing, the sponsorship or exhibition space will not be cancelled and the full amount will still be payable.
- 9. After a sponsorship or exhibition package has been confirmed, a reduction in a sponsorship size or withdrawing from an exhibition package will be considered a cancellation and will be governed by the cancellation policy.

Disclaimer

- 10. The Organisers reserve the right to change the date and duration of the Event if exceptional circumstances demand. In the event of change of date and/or duration, the agreement to participate will remain in force as long as the Sponsor/Exhibitor is informed at least 30 days before changes.
- 11. Should, for any reason outside the control of PHAA, the venue change or the event be cancelled, PHAA will endeavour to reschedule. In this instance the sponsor/exhibitor will indemnify and hold PHAA harmless from and against any and all costs, damages and expenses.

- 13. Neither party shall be liable in damages or have the right to terminate this Agreement for any delay or default in performing hereunder if such delay or default is caused by conditions beyond the reasonable control of the party whose performance is affected.

Exhibition Space and Materials

- 15. It is the Sponsors and/or Exhibitors responsibility to ensure they have adequate insurance coverage for the duration of the exhibition. Sponsors and/or exhibitors are required to have Public Liability coverage based on a Limit of Indemnity of AUD\$10,000,000 for any one occurrence.
- 16. In the event that PHAA is required to rearrange the floor plan and/or relocate any exhibit, PHAA will consult with the affected exhibitors on alternative arrangements. PHAA will not discount or refund for any facilities not used or not required. PHAA reserves the right to require removal of any display items that are not consistent with Item 1 of these Terms and Conditions.
- 17. No Sponsor or Exhibitor shall assign, sublet, or apportion the whole or any part of their sponsorship package or booked trade exhibition space except upon written consent of the PHAA.
